
ADVISORY AND SOLVENCY HEARING

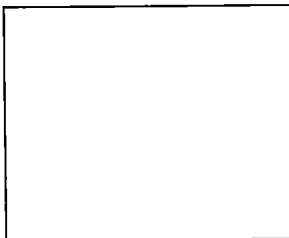
- A. Defendant has advised the Court that he has retained counsel or will retain counsel.
