Miller was shirtless, sweating profusely, and had several open wounds on his face that were bleeding heavily. Miller's injuries did not appear permanent and he later refused medical attention. Miller advised the other male later identified as Sean A Valentine (wm; 07/18/1993) was still at the aforementioned address and was possibly hurting the female. The female in the incident was later identified as Cristen A Giles (wf; 01/09/1991). There was no one else in the vehicle with Miller, so I responded to the address to make contact with the other involved parties and ensure the welfare of all the individuals involved. PFC Counts remained with Miller and obtained his sworn statement. PFC Count later advised me that Miller stated, Valentine arrived at the residence unannounced and uninvited by Giles. Miller stated Valentine began banging on the door and eventually kicking it in. Miller advised Valentine punched him multiple times and he had to resort to defending himself and Giles. Miller advised Valentine and him continued to fight outside, before he left then area in his truck. At the conclusion of his statement, Miller wished to prosecute Valentine for battery. Upon my arrival, multiple residents were outside the apartment building stating Valentine and Giles were still inside the apartment. I walked up the stairs urgently to the third floor. There was blood spots on each level of the stairs. When I got the third floor, I saw a large amount of blood in the corner of the hallway. I could hear screaming coming from inside the residence, exigent circumstances existed, so I asked over the radio where my nearest backup was before entering the residence.

The front door was unlocked and did not appear kicked in, I entered with my department issued Axon Taser drawn and turned on. I immediately observed Valentine standing outside the hallway bathroom, he was completely naked and was bleeding from a cut on his head. I gave Valentine multiple commands to come to me and he refused. Valentine then walked into the back bedroom still refusing to comply with my commands, so I followed him, still having my Taser drawn and pointed at his back. Valentine attempted to enter the bathroom inside the bedroom, I holstered my Taser and attempted to secure him in handcuffs. I grabbed Valentine's left arm and then his right, Valentine then tensed his arms and attempted to pull away. Valentine was yelling and cursing at me in the handcuffing process. I turned him toward the bed, he slipped and fell on the bed. I was then able to secure him in handcuffs and faced him toward the wall and leaned him against a nightstand.

Ofc Anderson #313 arrived on scene and helped me secure Valentine before returning to Giles and obtaining her sworn statement. Ofc Anderson later advised me that Giles stated Valentine did arrive unannounced and uninvited. Giles's statements were similar to Miller's and at the conclusion she did not wish to prosecute Valentine for crimes he committed against her. See Ofc Anderson's supplemental report for further.

MPO Banegas #328 arrived assisted me with Valentine in the back bedroom. I was holding Valentine's left arm and MPO Banegas was holding his right. We were attempting to locate Valentine clothes before removing him from the room. Valentine tensed and braced himself and pushed himself against the nightstand and attempted to right himself. MPO Banegas and I pushed Valentine forward placing his face against the mirror of the nightstand. Valentine finally calmed down enough for MPO Banegas and I to escort out of the room and place him in a pair of pants before placing him in my patrol vehicle.

Based on my above investigation and statements provided, I found probable cause that Sean A Valentine was the primary aggressor to the incident and arrested him for simple battery. I also charged him and resisting an officer without violence. I transported Valentine to the Jupiter Medical Center for medical clearance and he was ultimately booked into the Palm Beach County Jail without incident.

I could hear screaming coming from inside the residence, exigent circumstances existed, so I asked over the radio where my nearest backup was before entering the residence.

The front door was unlocked and did not appear kicked in, I entered with my department issued Axon Taser drawn and turned on. I immediately observed Valentine standing outside the hallway bathroom, he was completely naked and was bleeding from a cut on his head. I gave Valentine multiple commands to come to me and he refused. Valentine then walked into the back bedroom still refusing to comply with my commands, so I followed him, still having my Taser drawn and pointed at his back. Valentine attempted to enter the bathroom inside the bedroom, he was not taking an aggressive posture but was still verbally uncompliant. I holstered my Taser and attempted to secure him in handcuffs. I grabbed Valentine's left arm and then his right, Valentine then tensed his arms and attempted to pull away. Valentine was yelling and cursing at me in the handcuffing process. I turned him toward the bed, he slipped and fell on the bed. I stood him up and he attempted to pull away again. Giles approached Valentine and calmed him down enough for me to gain compliance and secured him in handcuffs.

Ofc Anderson #313 arrived on scene and spoke with Giles and obtained her sworn statement. Ofc Anderson later advised me that Giles stated Valentine did arrive unannounced and uninvited. Giles's statements were similar to Miller's and at the conclusion she did not wish to prosecute Valentine for crimes he committed against her. See Ofc Anderson's supplemental report for further.

I faced Valentine toward the wall and leaned him against a nightstand and waited for additional units. MPO Banegas

We were attempting to locate Valentine clothes before removing him from the room. Valentine tensed and braced himself and pushed himself against the nightstand and attempted to right himself. MPO Banegas and I pushed Valentine forward placing his face against the mirror of the nightstand. Valentine finally calmed down enough for MPO Banegas and me to escort him out of the room and place him in a pair of pants before placing him in my patrol vehicle.

Based on my above investigation and statements provided, I found probable cause that Sean A Valentine was the primary aggressor to the incident and arrested him for simple battery. I also charged him with resisting an officer without violence. I transported Valentine to the Jupiter Medical Center for medical clearance and he was ultimately booked into the Palm Beach County Jail without incident.

On 6/19/21 at 0049 hours, I responded to 1605 South US Highway 1 unit V6304 in Jupiter, Florida in reference to several 9-1-1 calls for possibly two males and a female involved in a physical altercation.

My body worn camera was activated upon arrival.

Upon arrival, Officer Schneider ID 330 had already made entry in to the residence and had a W/M in custody. I entered the residence and located a W/F (later identified as Cristen Giles DOB 1/9/91) inside the bedroom where Officer Schneider had a naked male in custody. I escorted Ms. Giles in to the kitchen and observed blood on several areas of her body. I asked Ms. Giles if any of the blood was hers and she denied being injured. I checked and confirmed that she did not have any open wounds or abrasions on her body. Ms. Giles was distraught, crying and asking for us to get the male clothes. Officer Banegas ID 328 arrived on scene and assisted Officer Schneider in escorted the male out and getting him dressed.

I asked Ms. Giles to explain what happened and she stated the following. It is a summary of my interview, and not purported to be verbatim.

Ms. Giles advised she had gone out to dinner with her ex fiance, Justin Miller DOB 11/4/88 and then came back to her apartment. She said she was sitting on the couch with Mr. Miller, when she heard a loud bang come from either the hallway or the door. She advised her ex boyfriend, W/M Sean Valentine DOB 7/18/93 entered her residence uninvited. Mr. Valentine does not reside there and was not invited over. She said he began to yell and pushed Mr. Miller back down on the couch. They began to shove each other inside of the apartment and she said she ran out of the house to get help. Ms. Giles advised they ultimately continued down the hallway and began fist fighting. She attempted to intervene but advised she was shoved up against the wall and pretended to be injured in an attempt to get them to stop fighting. She said it did not work and they continued to fist fight. She ran downstairs for help and made contact with two neighbors on the second floor. She said they brought her in to their apartment and called 9-1-1. Ms. Giles advised she was concerned for Mr. Miller and Mr. Valentine so she left the apartment and went back upstairs. She explained that Mr. Valentine followed her back in to the apartment but did not know where Mr. Miller went. Ms. Giles advised she told Mr. Valentine to get in the shower because he was covered in blood and that is when Officer Schneider arrived.

Ms. Giles did not wish to prosecute for the residential burglary. Officer Yochum ID 383 arrived on scene and took photographs of Ms. Giles and I provided her with a case card.

I spoke with a caller/witness, W/M Gavin Hopewood DOB 5/7/91 who advised he heard a woman screaming from his unit across the street. He stated he saw two males fighting and believed that the woman was also involved. He said he

**MY DEPARTMENT ISSUED BWC WAS UTILIZED DURING THE BELOW DESCRIBED INCIDENT:**

On Friday, 06/18/21, I arrived at 1605 S. US Hwy-1 V6304, in reference to assisting officers with a possible fight in progress call for service.

Prior to my arrival I heard Officer Schneider, who was the first Officer on scene, advise he heard screaming from apartment 304 and that there was copious amounts of blood in the hallway leading to the apartment. As I arrived on scene, I saw Officer Anderson hastily rushing up the apartment building stairwell. I exited my vehicle and followed her upstairs. Since I was approximately 50yds behind Officer Anderson, she was already inside the apartment as I entered.

Upon entering the apartment, I saw Officer Anderson escorting Cristen Giles (w/f, 01/09/91) into the kitchen and heard a male yelling from inside a room. I walked into the room and saw Officer Schneider controlling a naked male, later identified as Sean Valentine (w/m, 07/18/93). Sean was continually screaming and sweating profusely. He was completely naked and Officer Schneider had him pinned against a dresser inside the room. I immediately walked over to assist and control Sean by his right arm. After a few seconds Sean's behavior became increasingly agitated and he began yelling loudly again then attempted to stand straight up as he pushed back against Officer Schneider and me. I then pinned Sean onto the top of the dresser using an arm lock and held him until he agreed to comply with Officer Schneider and me.

At this time Officer Schneider and I escorted Sean out of the bedroom, put pants on him, walked him down the stairs and secured him in the back of Officer Schneider's vehicle. Palm Beach County Fire Rescue was notified and responded to check on Sean's medical condition and he was cleared to be transported by Law Enforcement. As a result of Officer Schneider subsequent investigation, Sean was arrested. He was transported to the Jupiter Medical Center for medical clearance. This concluded my involvement with this incident.
