The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was stopped for driving erratically after he was stopped at a green light, made a late turn after stopping in the roadway, stopping past the stop bar at two stop signs, and making an improper turn from the through lane after stopping in the middle of an intersection. The defendant was driving a 2018 Subaru SUV, bearing FL tag IKEV99. Upon making contact with the defendant, he displayed several signs of impairment, including: slurred speech, a strong odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, swaying, difficulty answering simple routine questions, and an admission to consuming alcoholic beverages. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .194/.203.

The defendant identified himself via his FL driver's license.
