The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, at Lynn Rd / Paddock Trail Dr within Hillsborough County, the affiant responded to a traffic crash call for service reference an impaired driver (crash report #89442408). The witness was involved in the traffic crash and observed the defendant in the driver seat of the vehicle at the time of the incident. The total victim and witness property damage was \$8,000. Deputy W. Orndorff #254197 made contact with the defendant and observed him to have indicators of impairment. Upon contact with the defendant, he emitted a strong odor of an alcoholic beverage from his breath, had bloodshot and watery eyes, and an unstable balance. Field sobriety exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples. The first BrAC sample was .091 and the second BrAC sample was .084. The defendant was identified via a valid Florida DL.
