The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, Deputy Brown #258201 and Corporal Grice #4995 contacted the defendant, who was the driver of a silver, 2013 Kia Sorrento bearing FL tag IN84PL after responding to a traffic crash (DHSMV 89441256). I met with the listed victim, Xochitl Zapata Morales who witnessed the crash and was also the driver of a silver, 2002 GMC pickup bearing FL tag VDD974. Zapata Morales verbally identified the defendant as the driver of the Kia Sorrento by identifying the stripped dress the defendant was wearing, and observed her exit the vehicle immediately after the crash. The second victim and property owner of a copper, 2015 Honda CRV bearing FL tag LBNJ15, Yariza Marin, was not driving or in the vehicle during the time of the crash. The driver of the before mentioned vehicle, Edward Williams Jr was transported to Brandon Regional Hospital with minor injuries. The total damages sustained from the crash were estimated to be approximately \$8000.00 dollars.

Upon contact with the defendant, she emitted an odor of an alcoholic beverage from her breath, she had slurred speech, she had bloodshot and watery eyes, and unstable balance. Field sobriety exercises were conducted and impairment was observed. The defendant was arrested for DUI and refused to provide two lawful breath samples after Implied Consent warning was read and understood. It should be noted, the defendant initially agreed to provide two lawful samples of her breath, a total of four breath samples were attempted to be taken but the defendant failed to follow the instructions given and did not cooperate. The defendant admitted having consumed three, Long Island Iced Teas and two, glasses of red, Moscato wine prior to the traffic crash tonight during post-Miranda interview. The driver was identified via a valid Florida DL.
