

In the State of Florida, County of Palm Beach, City of Boynton Beach, I, Officer Acosta, with the Boynton Beach Police Department was assisting on a traffic accident in the area of 1500 South Federal Highway. While assisting on the accident, I observed a gray Jeep Grand Cherokee traveling southbound on Federal Highway at a high rate of speed. At the intersection of Woolbright Road and Federal Highway the vehicle attempted to make a left turn in order to travel eastbound on Woolbright Road; However, the vehicle lost traction, hopped on the curb, and collided with a metal pole. The operator of the vehicle who was later identified as white male, Seth Morris accelerated and attempted to leave the scene of the crash (Refer to BBPD case number 20026454). At this time, I ran and got into my marked patrol vehicle (4556) and activated my lights and sirens. The Jeep continued eastbound at a high rate of speed disregarding my emergency signals. While traveling eastbound, I lost visual of the vehicle prior to approaching Ocean Blvd. I then turn southbound on Ocean Blvd and at 5600 North Ocean Blvd I located the vehicle attempting to enter the Ocean Ridge Yacht Club. I was then able to read the Florida license plate (FL/969QHZ) as I positioned my vehicle behind the Jeep. As I then began to exit from my vehicle Morris decided to speed into the community, disregarding my emergency signals to stop.

I followed the vehicle into the community and in front of 5564A North Ocean Blvd the vehicle came to an abrupt stop causing my vehicle to almost collide with the Jeep. I was able to stop my vehicle to the right side of the Jeep as Morris attempted to exit from the vehicle and flee. I immediately exited from my vehicle and withdrew my gun from my holster and pointed at Morris. As I gave commands to Morris, I could see the back of a handgun tucked into his waistband. I gave clear and concise commands to Morris to get on the ground with his arms forward, which he complied with. As I approached Morris from behind, I attempted to grab his hands in order to detain him at which time he began to resist. Morris did not allow me to grip his hands and attempted to push up. Subsequently, Officer Davis who was then approaching us was forced to push Morris head down which resulted with Morris sustaining a small laceration to his head. I was then able to gain leverage of Morris hands and he was then detained. Morris was scene and treated by Boynton Beach Fire Rescue on Scene and then transported to Bethesda Memorial Hospital East for medical clearance for jail.

Based on the above facts, Seth Morris was placed under arrest and charged with one count of Fleeing and Eluding pursuant F.S.S. 316.1935, one count of Resisting Arrest without Violence pursuant F.S.S. 843.02, and one count of Hit and Run pursuant F.S.S. 316.061. Morris was then transported to the Boynton Beach Police Department for processing and later turned over to Palm Beach County Jail.
