Probable Cause Affidavit

Before me this date personally appeared MORALES, DAVID J. (18276) who being first duly sworn deposes and says that on 1 day of May, (year) 2017 at 5000 JOHNSON RD, COCONUT CREEK, FL 33073 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

2001 brown Mercury Grand Marquis FL Tag# Z1TNW, while he was under the influence of an alcoholic beverage or chemical substance to the extent that his normal faculties were impaired.

On the above date and time I was conducting moving radar enforcement in the 5000 block of Johnson Rd. heading westbound as I observed the aforementioned vehicle traveling eastbound at a high rate of speed. With my department radar activated (Stalker# 5593) I was able to obtain a read out put of 58 m.p.h. in a 30 m.p.h. I made a u-turn and got behind the vehicle to conduct a traffic stop. The final stop was in the 4400 block of Johnson Rd.

Upon approaching the vehicle, I observed Gurian as the sole occupant of the vehicle. I asked Gurian for his license, registration, and proof of insurance. While Gurian was searching for his documents I requested, I was able to observe (2) open bottle of Rolling Rock beer bottles on the floor open. Gurian had bloodshot watery eyes and had slurred speech. I asked Gurian where he was coming from which he stated Delray Beach, FL. I asked Gurian where he was heading and he said the casino. I asked Gurian how did he get to the casino which he stated I-95 to Sample Rd. It should be noted that Sample Rd. is located approximately 2 miles away from the stop and final rest location. Based on my observations, I had Gurian step out of his vehicle and to the rear.

While walking to the rear of the car, Gurian was uneasy on his feet with a slight sway while standing. Once at the rear of the vehicle, I could still smell an odor of an alcoholic beverage emitting from his breath. I asked Gurian what he had to drink. Gurian stated he had (2) beers and (1) shot over a period of time. I stated to Gurian

Probable Cause Affidavit

Before me this date personally appeared MORALES, DAVID J. (18276) who being first duly sworn deposes and says that on 1 day of May, (year) 2017 at 5000 JOHNSON RD, COCONUT CREEK, FL 33073 (crime location)

(the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

that I am conducting a DUI investigation and asked if he would be willing to submit to some roadside exercises to determine his ability to operate a motor vehicle. Gurian stated he would.

The exercises are as follows:

1. Horizontal Gaze Nystagmus: Gurian had all 6 cues. Gurian lacked smooth pursuit in both his left and right eye, distinct and sustained nystagmus at maximum deviation in both his left and right eye, and onset of nystagmus prior to 45 degrees in both his left and right eye.

2. Walk and Turn- While explaining the walk and turn to Gurian, he was unable to get into the starting position that I was demonstrating. Gurian stated to go ahead and end the exercises. I told Gurian that my determination to arrest him for DUI would be based on my observations of his bloodshot watery eyes, driving pattern, and the odor of an alcoholic beverage emitting from his breath. Gurian stated he understood and wanted to be taken into custody.

At 1900 hours, I took Gurian into custody. I asked Gurian if he would submit to a breath test to determine its alcoholic content which he stated he would. While being transported to the CCPD jail for processing, Gurian stated he knows he messed up and it's all his fault and that he takes responsibility.

While at the CCPD jail, I began my (20) minutes observation of Gurian at 1935 hours. I completed my observation period at 1955 hours with no complication or abnormalities.
