- 2. Walk and Turn- While explaining the walk and turn to Gurian, he was unable to get into the starting position that I was demonstrating. Gurian stated to go ahead and end the exercises. I told Gurian that my determination to arrest him for DUI would be based on my observations of his bloodshot watery eyes, driving pattern, and the odor of an alcoholic beverage emitting from his breath. Gurian stated he understood and wanted to be taken into custody.

At 1900 hours, I took Gurian into custody. I asked Gurian if he would submit to a breath test to determine its alcoholic content which he stated he would. While being transported to the CCPD jail for processing, Gurian stated he knows he messed up and it's all his fault and that he takes responsibility.

While at the CCPD jail, I began my (20) minutes observation of Gurian at 1935 hours. I completed my observation period at 1955 hours with no complication or abnormalities.
