The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/09/2020, at approximately 1800 hours at 14500 46th St N APT #405 Tampa, FL-33613, the defendant, Shaikh Monirul Islam Habibullah, actually and intentionally slapped the victim, Anzalik Ahmed, in the face one time as well as grabbed the victim with one hand by the neck to attempt to push the victim out of the apartment. The victim did not lose consciousness or the ability to breath during the incident.
