The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On the listed offense date, time, and location, your affiant responded to a single vehicle crash versus a light pole. Upon arrival on scene, your affiant observed damage to a 2015 Gray Ford Fusion (Illinois Tag #AG38713) and a Selmon Expressway light pole dislodged from its base and broken on the ground. Contact was made with two (2) independent witnesses who directed law enforcement to the defendant (Shane Mckee), and stated he was the driver. Upon contact with the defendant, several indicators of impairment were detected such as the odor of an alcoholic beverage, his eyes were watery and glassy, and his speech was slurred. Deputy P. Davis (257236) responded and conducted the traffic crash investigation. Once her investigation was completed, I initiated a criminal DUI investigation. I interviewed the witnesses under verbal oath and they identified the defendant as the individual in operation of the vehicle during the crash and who they observed exit the driver seat holding two Shock Top beer bottles. I made contact and read the defendant his Miranda warnings, explaining I was beginning a DUI investigation, and conducted an interview. Post-Miranda, the defendant admitted he was drunk and should not be driving. He advised he drank two (2) vodka soda drinks prior to operating his motor vehicle. The defendant consented to and performed roadside Standardized Field Sobriety Exercises (SFSE) not to a satisfactory performance, with multiple additional indicators of impairment observed. The defendant was arrested on scene for DUI with property damage (estimated combined total of \$30,000). The defendant was transported to CBT, and after a twenty (20) minute observation period, the defendant two breath samples of .283% and .294% via HCSO Intoxilyzor 8000 (S/N #80-000808). The defendant was positively identified via Florida Driver License.
