THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACILITIES WERE IMPAIRED.

WHILE ENTERING THE ROUNDABOUT FROM CORONADO DR, I OBSERVED A GRAY SEDAN IN THE ROUNDABOUT IN THE INSIDE LANE TRAVELING AT A HIGH RATE OF SPEED. THE VEHICLE TOOK THE TURN SO WIDE THE VEHICLE ENTERED INTO THE OUTSIDE LANE WHILE EXITING THE ROUNDABOUT WITHOUT SIGNALING A LANE CHANGE. I ATTEMPTED TO CATCH UP TO THE VEHICLE IN A 30MPH ZONE AND PACED THE VEHICLE FOR A QUARTER OF A MILE TRAVELING AT 60MPH. THE VEHICLE MADE TWO OTHER LANE CHANGES WITHOUT THE USE OF A TURN SIGNAL IN CLOSE PROXIMITY TO OTHER VEHICLES. I ACTIVATED MY EMERGENCY LIGHTS AND SIRENS AND THE VEHICLE DID NOT IMMEDIATELY STOP BUT TRAVELED FOR APPROXIMATELY A QUARTER MILE BEFORE THE VEHICLE CAME TO A STOP. UPON APPROACH, THE VEHICLE BEGAN TO MOVE FORWARD AS THE DRIVER FORGOT TO PLACE THE VEHICLE IN PARK. UPON CONTACT WITH THE DRIVER, I OBSERVED A STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM INSIDE. I REQUESTED THE DRIVER TO STEP OUT AND OBSERVED A HEAVY SWAY AS WE WALKED BACK TO THE BACK OF HIS VEHICLE. HIS EYES WERE BLOODSHOT AND WATERY AND HE EXHIBITED SLURRED SPEECH. HE REFUSED SFST'S AND A BREATH TEST.

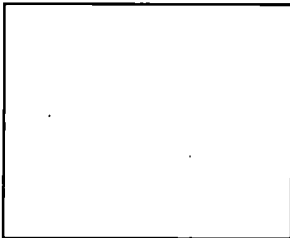
