The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a 2016 black Volkswagen bearing a Florida license plate of B4MTK. He was traveling east on Kennedy Blvd and approached a red light at N. Ashley Drive. However, the defendant came to a stop over the line of prolongation. In addition, a license plate check was conducted and revealed the registered owner (defendant) had a suspended drivers license for failure to appear on a traffic summons. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and when your affiant tired to place a handcuff on the defendant resisted arrest by tensing his arms, twisting his body away from me, tried to pull away, and refused to put his hand behind his back. The defendant was eventually placed in handcuffs. He later submitted to a breath test which had a BrAC result of .111/.105. A search of the defendants vehicle also revealed two small clear plastic bags in the trunk containing a white powder. Both bags field tested positive for cocaine and is less than one gram. The defendant was identified by his FL DL.
