The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, Deputy Conti made contact with the driver after being dispatched to an "Assist Other Agency" call for service. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from her breath, she had slurred speech, she had fumbling fingers while retrieving her documents, she had bloodshot and watery eyes, was covered in vomit, and had unstable balance.
