 On 7/25/2020, at approximately 0314 hours, at Dale Mabry Hw / South Av W., Tampa, FL 33614, I conducted a traffic stop on a black Dodge Ram 1500 (bearing SC tag SAR956 / VIN: 1C6RRELT3KN549186) for operating on the roadway without illuminated tail lights/headlights. The defendant was observed to have glassy, bloodshot eyes, slurred speech, and he struggled locating the requested documentation for his vehicle (registration/insurance). The defendant was given the opportunity to perform field sobriety exercises, which he did poorly indicating impairment. Subsequent to arrest, the defendant provided breath samples of .137/.135. The defendant identified himself verbally, which was identified via their South Carolina driver's license.
