The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was stopped for failing to drive within her lane and for tailgating other vehicles. Upon stopping the defendant, a St. Petersburg Police Officer that was on his way home stopped behind me and informed me that the defendant had cut him off prior to me stopping her. Upon making contact with the defendant, who was identified by her Florida driver's license, I observed that her eyes were glassy and there was a strong odor of an alcoholic beverage emitting from her breath. Defendant allowed me to check her eyes and I observed 6 point nystagmus. Defendant admitted consuming alcohol in Soho prior to driving, and also admitted cutting off the St. Petersburg Police Officer, who she said was driving too slow. The defendant refused to perform additional SFST's and was arrested for DUI. I transported the defendant to CBT where she was administered a breath test. Defendant's BrAC measured .190 / .211 / .213 This occurred in Hillsborough County, Florida.
