The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 8/9/2019 at approximately 9:13pm, I was dispatched to a two vehicle collision located at US-41 and Cockroach Bay Blvd. Upon arrival, I spoke with the defendant who advised he was drunk and had been in a collision. Hillsborough County Sherriff Office Deputy J. Reynolds, badge number 257778, advised that upon his arrival on scene, he observed the defendant exit from the driver's door from the vehicle. I completed my crash investigation and informed the defendant I would be conducting a DUI investigation. I asked the defendant if he would be willing to perform Field Sobriety Exercises to which he agreed. The defendant performed poorly. The defendant was arrested for the listed charges. I asked TBRCC to run a criminal history check on the defendant to which the defendant had two prior DUI's. I then transported the defendant to Central Breath Testing located at Orient Road Jail. I asked the defendant if he would be willing to provide a sample of his breath in order to determine its alcohol contents to which the defendant agreed. The defendant provided two samples of .154 and .167. The defendant was booked for the listed charges.
