Defendant admitted consuming alcoholic beverages before driving and consented to perform SFST's. Defendant was unable to perform SFST's satisfactorily and post Miranda admitted that he should not have been driving. Defendant was arrested for DUI and was transported to CBT where he was read implied consent. Defendant refused a breath test. This occurred in Hillsborough County, Florida.
