The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/10/2021, at approximately 2231 hours, the defendant was operating a black Dodge Challenger, bearing Florida tag PEJU55 (VIN:2C3CDZAG5JH241538), and traveling on Falkenburg Rd. The black Dodge Challenger failed to yield the right of way while attempting to turn onto the Selmon Expressway and struck another vehicle. Total estimated value of property damage is \$25,000. The affiant arrived on scene shortly after the accident occurred and observed the defendant sitting in the drivers seat with her seat belt fastened (HCSO Case #21-83929 /DHSMV #89444339). The affiant detected signs of impairment from the defendant and requested the defendant perform Standard Field Sobriety Exercises (SFSES), which the defendant agreed to perform. During the SFSES, the defendant exhibited multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT where she refused to provide lawful samples of her breath after Implied Consent was read and understood. The defendant was positively identified via her Valid Florida driver's license.
