The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: 05/06/2020, at approximately 2327 hours, near the intersection of Highway 41 North and Big Bend Road, Apollo Beach, Florida 33572 the defendant was observed by Corporal A. Randall ABN: 228776 stopped at an active control device. Corporal Randall observed the defendant/driver in physical control of a tan 2010 Toyota Camry LE bearing Florida tag GYVA05 with an assigned VIN of 4T1BF3EK5AU044133 sitting through two cycles of a traffic control device on Highway 41 northbound. As a result, Corporal Randall made contact with the defendant and observed several indicators of impairment. Upon the affiant's contact with the defendant, I smelled the odor of an alcoholic beverage emitting from her breath, she had slurred speech, watery/glassy eyes, and she was unsteady on her feet. The defendant elected to participate in field sobriety exercise and while doing so, she showed further indicators of impairment. The defendant was placed under arrest and transported to Central Breath Testing where she provided one lawful breath samples of .128. The defendant refused to provide two lawful breath samples. The defendant was read Implied Consent and she continued to refuse by not properly proving the second sample (pulling away from the instrument, not attempting to blow, and blowing on the breath technician's arm). The defendant identified herself verbally. I further identified the defendant via her DAVID photograph.
