The caller continued to follow the BMW into the town of Jupiter in my jurisdiction and advised that it was all over the road and unable to maintain a lane.</p> <p>While en-route to the area, I saw the BMW traveling Northbound on S ALT ALA passing Admirals Cove with a left headlamp out and the caller following from a safe distance. I was able to turn around and get behind the gray BMW and confirmed it was the same FL tag and vehicle. The vehicle was unable to maintain a single lane of travel and was paced by my certified vehicle #1602 traveling approximately 62MPH in a posted 45MPH zone.</p> <p>I then attempted to conduct a traffic stop on the vehicle by activating my emergency overhead lights in my fully marked Jupiter Police Department vehicle #1602. The vehicle was slow to stop and continued to swerve between the middle, left, and right lane of the three lane roadway. The vehicle finally came to a stop in the right turn lane just before the intersection of S Alt Ala and Indiantown Rd.</p> <p>I made contact with the registered owner of the vehicle and driver, Shelley Stanoch (W/F 06/06/1957) who was later identified by her Florida DL. I explained my reason for my traffic stop to Stanoch and asked if she was suffering from any type of medical episode or taking any type of medications that might make her have any medical reactions, to which she replied "no". I then asked Stanoch for her license and paperwork for the vehicle to which she had a difficult time finding, however, was able to present. I asked Stanoch where she was headed and if she had consumed any alcohol this evening. She replied stating that she had a few drinks at a golf event and was attempting to drive to</p>

a friend's house in Abacoa, which was in the opposite direction of where she was driving. Stanoch had blood-shot glassy eyes, slurred/slowed speech and the odor of an unknown alcoholic beverage emanating from her breath that intensified as she spoke. Based on her driving pattern, and multiple indications of impairment, I believed Stanoch was under the influence and asked her to step out of her vehicle.

I advised Stanoch that I wished to conduct Standard Field Sobriety Tasks (SFST) based on the aforementioned events. It was difficult to maintain Stanoch's attention as she continued to cry and look around. She refused to participate in the SFSTs after explaining what they were and the purpose multiple times. I then read Stanoch her Taylor warnings from a pre-printed template. She then agreed to participate, however, I was only able to conduct the HORIZONTAL GAZE NYSTAGMUS (HGN) which she displayed the following:

- No resting nystagmus in either eye
- Both eyes tracked together equally
- Lack of smooth pursuit in both eyes
- Distinct and sustained nystagmus at maximum deviation in both eyes
- Onset of nystagmus prior to 45 degrees in both eyes
- No vertical nystagmus in either eye.

After completing this task, I attempted to move on and instruct the next task which was the Walk & Turn, however, Stanoch continued to cry and not answer any questions. I gave Stanoch multiple opportunities to continue with the tasks and re-read her Taylor warnings. Stanoch continued to cry and refused to answer my question if she would continue the tasks and was advised that her silence would be taken as a refusal.

Stanoch was subsequently placed into handcuffs that were double-locked and checked for proper spacing per department policy for suspected driving under the influence. It was also discovered that Stanoch had urinated on herself while conducting a search of her person incident to arrest. I then placed Stanoch in the rear of my patrol vehicle and read her the Jupiter Police Department Roadside DUI Breath request. Stanoch refused to state her name, address, date of birth, etc. However, I presented her all of her information off of her Florida DL, to which she agreed accurate. Stanoch ultimately refused to submit to lawful test of her breath. I read Stanoch implied consent from a pre-printed document twice because she did not understand the first time, however, she still subsequently refused and asked for a lawyer.

Stanoch was then transported to the Jupiter Police Department to complete all necessary paperwork and subsequently transported to the Palm Beach County Jail without incident.

The above incident was captured on Body Worn Camera. This is a summary of the events and not purported to be verbatim.

Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
