On December 7, 2020 I was assigned Boca Raton Police Department case number 2020-13701 for follow-up (aggravated assault).

On December 6, 2020 at approximately 1554hrs, Boca Raton Police Officers responded to 700 E Palmetto Park Rd in reference to an aggravated assault (vehicular). Upon their arrival, they met with a witness, w/m Daniel Hutchinson and one of the victims, w/m/j Gavin Long (DOB 2/1/07).

Hutchinson advised that he picked up Long who was running toward him asking for help. When Long got into his vehicle, he appeared frantic/scared, stating that a man was chasing him with his vehicle. Furthermore, Hutchinson explained that he witnessed a black Bentley driving recklessly eastbound over the Palmetto Park bridge. When the Bentley came over the bridge, he saw the vehicle swerve onto the shoulder/sidewalk in the direction of a juvenile that was riding a bicycle. As a result of these actions, the juvenile fell off his bicycle injuring his knee (bleeding). The driver of the Bentley then exited and began confronting the juvenile. Hutchinson felt that the driver of the Bentley may have been intoxicated based upon his driving pattern and that he almost struck a juvenile with his vehicle.

After meeting with Hutchinson, BRPD Officer Bachar, met with Long to obtain a sworn statement. The following is a synopsis of Long's statement.

He and friend, w/m Dante Ambrose (DOB 12/5/05), were at Mizner Park earlier today where they ran into his ex-girlfriend, w/f/j Ava Large (DOB 5/15/08). When Large walked away, Long picked up her bag then dropped it prior to leaving Mizner Park. He and Ambrose then left the area on their bicycles. As they were riding eastbound at the 600 block of E Palmetto Park Rd, they noticed a black Bentley driven by Large's father, w/m Sherief Abu-Moustafa, traveling at a high rate of speed towards them. The vehicle then stopped

As they got to the bottom of the bridge, the Bentley continued chasing them. At this point, Long rode his bicycle northbound into the neighborhood because he was scared. While being chased by the Bentley, Long feared for his life as he was almost struck by it.</p> <p>After speaking with Long, BRPD Officer Bachar met with Ambrose to obtain a sworn statement. The following is a synopsis of Ambrose's statement.</p> <p>He and Long were at Mizner Park earlier today when they ran into Long's ex-girlfriend, w/f/j Ava Large (5/15/08). Long and Large began cursing at each other at Mizner Park and then Large walked away leaving her bag unattended. Long then picked up the bag but returned it prior to leaving Mizner Park. They then left the area on their bicycles towards E Palmetto Park Rd. As they were approaching the Palmetto Park bridge (westside), a black Bentley was approaching them at high rate of speed and attempting to strike them. The driver, Sherief Abu-Moustafa, then exited the vehicle and chased after them on foot. Fearing that Abu-Moustafa would harm them, they continued riding their bicycles eastbound over the bridge. As they got to the bottom of the eastside of the bridge, the Bentley was being driven recklessly over the bridge at approximately 70mph in a posted 35mph zone. Once over the bridge the vehicle swerved in their direction on the southside of the roadway. To avoid being struck by the Bentley, Ambrose had to swerve out of the way, which caused him to fall and injure himself (bleeding from knee). Ambrose got up, back on his bicycle and rode off to get away from Abu-Moustafa. As he was riding through the neighborhood, Abu-Moustafa continued following in the Bentley. Ambrose stated that he was in fear for his life as he was almost runover by Abu-Moustafa's Bentley.</p> <p>It should be noted that both Long and Ambrose stated that Abu-Moustafa was reaching for his waistband as if he had a weapon. Neither of them observed a weapon during the encounter.</p> <p>Both Long and Ambrose positively identified Abu-Moustafa through photo arrays as the suspect who assaulted them.</p> <p>Another witness, Kyle Saboda, contacted BRPD Officers to inform them what he observed. Saboda stated that he and his girlfriend were walking eastbound on the Palmetto Park bridge when they heard a vehicle revving the engine then driving in a "zig zag" manner towards one of the victims causing him to fall off his bicycle. Saboda confirmed that the suspect vehicle was a black Bentley.</p> <p>It should be noted that an investigative query yielded that Abu-Moustafa has a 2020 Bentley bearing FL tag NMVD52) registered to him and that he resides at 150 NE 5th Ave, Boca Raton FL.</p>

<p>BRPD Officers Bachar and Posset later contacted Abu-Moustafa at his residence to speak with him about the allegations made during their investigation. Prior to questioning, Abu-Moustafa was read his Constitutional Rights by Officer Bachar. After being read his Constitutional Rights Abu-Moustafa agreed to speak with officers concerning his involvement. Abu-Moustafa stated that his stepdaughter, Ava Large, contacted him crying hysterically. She stated that Long and Ambrose were bullying her and her friends early at Mizner Park. He then drove over to Mizner Park to pick them up. As they were driving home, Large observed Long and Ambrose riding their bicycles on E Palmetto Park Rd. He decided that he would going to "scare" them by chasing them in his vehicle. He denied intentionally driving towards them trying to strike them with his vehicle. He admitted to exiting his vehicle at one point to confront them about bullying Large. He also denied driving recklessly or above the speed limit.</p> <p>On 12/7/20, BRPD Detective Lima and I met with Hutchinson to administer a photo array. It should be noted that Detective Lima administered the photo array as he was not involved with the investigation. Hutchinson positively identified Abu-Moustafa as the suspect who was driving the Bentley and chasing after the victims.</p> <p>Based upon the aforementioned information, it is clear and evident that Abu-Moustafa drove his vehicle towards both victims with the intent and appartent ability to harm them. By doing this, he created a well-founded fear that both victims would be harmed if struck by his vehicle.</p> <p>I have developed probable cause to arrest and charge w/m Sherief Abu-Moustafa with two (2) counts aggravated assault (vehicular) contrary to F.S.S. 784.021(1) (a), a 3rd degree felony.</p>

BRPD Officers Bachar and Posset later contacted Abu-Moustafa at his residence to speak with him about the allegations made during their investigation. Prior to questioning, Abu-Moustafa was read his Constitutional Rights by Officer Bachar. After being read his Constitutional Rights Abu-Moustafa agreed to speak with officers concerning his involvement. Abu-Moustafa stated that his stepdaughter, Ava Large, contacted him crying hysterically. She stated that Long and Ambrose were bullying her and her friends early at Mizner Park. He then drove over to Mizner Park to pick them up. As they were driving home, Large observed Long and Ambrose riding their bicycles on E Palmetto Park Rd. He decided that he would going to "scare" them by chasing them in his vehicle. He denied intentionally driving towards them trying to strike them with his vehicle. He admitted to exiting his vehicle at one point to confront them about bullying Large. He also denied driving recklessly or above the speed limit.

On 12/7/20, BRPD Detective Lima and I met with Hutchinson to administer a photo array. It should be noted that Detective Lima administered the photo array as he was not involved with the investigation. Hutchinson positively identified Abu-Moustafa as the suspect who was driving the Bentley and chasing after the victims.

Based upon the aforementioned information, it is clear and evident that Abu-Moustafa drove his vehicle towards both victims with the intent and apparent ability to harm them. By doing this, he created a well-founded fear that both victims would be harmed if struck by his vehicle.

I have developed probable cause to arrest and charge w/m Sherief Abu-Moustafa with two (2) counts aggravated assault (vehicular) contrary to F.S.S. 784.021(1)(a), a 3rd degree felony.
