On 10/03/2021 at 0347 hours I responded to the Cove apartments at 4003 West Shore Bl S to assist Tampa Master Patrol Officer Jason Fortney(49522) with a DUI investigation after he observed signs of impairment while investigating a traffic crash with property damage(\$35,000.00) in the parking lot. Upon my arrival I approached defendant Shobhit Jain, who crashed his silver 2021 Toyota Camry, FL tag DMRC59 into two legally parked unoccupied vehicles. Upon contact with the defendant I observed that he had extremely bloodshot glassy eyes and as I spoke with him I detected a distinct odor of an alcoholic beverage. Post Miranda the defendant admitted to driving at the time of the crash and also admitted that he drank "one beer". The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0408 hours. I then transported the defendant to the HCSO/CBT Facility where he submitted to a breath test. His BAC was .242/.254. I identified the defendant with a valid FL DL. The defendant was positively identified as the driver of his vehicle by the listed witness.
