 On the listed date and time, at Linebaugh Av W / Sheldon Rd within Hillsborough County, Deputy J. Tavano #258676
 contacted the driver on a welfare check. Deputy J. Tavano observed the defendant in the driver seat, slumped over behind the
 wheel, with the keys in the ignition. Upon contact with the defendant, he emitted an odor of an alcoholic beverage from his
 breath, he had slurred speech, had bloodshot and watery eyes, and an unstable balance. Field sobriety exercises were
 conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples. The
 first BrAC sample was .072 and the second was .067. Based on the BrAC not matching the level of impairment observed on
 scene, the affiant asked the defendant if he was willing to provide a urine sample. The defendant provided a urine sample
 after Implied Consent was read and understood. The defendant was identified via a valid Florida DL.
