The defendant was stopped after affiant observed her vehicle drifting and weaving in her lane, blocking the crosswalk at a red light, and straddling the left turn only and straight lane lane divider when making a left turn. The defendant was driving her 2005 Chevy Malibu, bearing FL tag #NLDK84. Upon making contact with the defendant, she displayed multiple indicators of impairment, including: slurred speech, an open container of "Jose Cuervo Pink Lemonade Margarita" in her back seat, bloodshot/glassy eyes, a strong odor of an alcoholic beverage on her breath, wearing two bar wristband on her right wrist, and an admission to drinking a couple of shots. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .184/.184.

The defendant identified herself via her FL driver's license.
