The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/07/2020, at approximately 0209 hours, Deputy V. Antonelli (ABN 25548) was on proactive patrol while traveling on E Bearss Ave. Deputy Antonelli observed a black Honda Fit, bearing Florida tag CXZQ95, to be traveling with no lights illuminated at night. Deputy Antonelli conducted a traffic stop on this vehicle in a parking lot located near the intersection of Livingston Ave and Irene St. Upon contact with the defendant, she was disoriented, she had bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Stanardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant refused to provide a lawful sample of her breath. The defendant was positively identified via her Florida driver's license.
