

On the 23 day of August, 2020 at 19:10 (Specifically include facts constituting cause for arrest)

On 08/23/2020 at approximately 1726 hours I responded to 6105 Town Colony Dr. Apt 524 in reference to a domestic disturbance. Upon arrival I met with the victim, Malgorzata Ekert who stated she was hit by her husband following an altercation. Officers Papia and Forbes were also on scene.

Malgorzata stated that earlier today, her and her husband, Slawomir Ekert met with a lawyer to sign divorce paperwork. It should be noted that they are filing for a divorce and have not been given a decree at this time. Upon arrival back to their residence, Malgorzata stated she walked the dog and then returned into the residence to call her mother. Their daughters, Nikola Ekert and Kaja Ekert were near the kitchen talking in English. Slawomir told Nikola to speak Polish whenever they are in the residence and Kaja told him that Nikola could speak English for practice. Malgorzata stated Slawomir felt disrespected and slapped Kaja because of her outburst. Malgorzata stated she told him not to touch Kaja like that he then became upset with her. Slawomir then told the daughters to go inside the room and closed the door behind them. She then stated he slapped her and grabbed Malgorzata by the neck and sat her on the dining room table. He then grabbed her cell phone from the kitchen counter and attempted to unlock her phone with the facial recognition. It should be noted that Malgorzata stated she was able to breathe and did not feel her airway was obstructed. Malgorzata feels that Slawomir thinks she is talking to someone else which is why he attempted to unlock her phone. She then stated he let her go in which she was able to grab her phone, run outside and yell for help. He then came up from behind her grabbing her and walked her back into the apartment. At this time, he grabbed their car keys, her cellphone and left the scene.

Officer Papia spoke to Kaja who stated Slawomir became upset over Nikola speaking English. Kaja stated she made a comment about allowing Nikola to speak English and Slawomir slapped her because of this. They were then both told to go into the room. Kaja stated she could hear arguing over the cellphone and opened the door to check on their

Kaja relayed she could see Slawomir grab Malgorzata by the neck.</p> <p>Officer Forbes spoke to Nikola separately who stated that Malgorzata became upset because of her speaking English. She then stated Kaja had giggled which is why she was slapped. Nikola relayed that she also heard the yelling and observed Slawomir grabbing Malgorzata by the neck.</p> <p>At 1839 hours I made contact with Slawomir via landline who stated he would return to the residence and speak with me. At approximately 1900 hours I made contact with Slawomir in the parking lot of his apartment building. Slawomir confirmed that him and Malgorzata had gotten into a verbal dispute but denies ever touching her or being touched. Slawomir also denies ever leaving with the vehicle or taking Malgorzata's phone. The vehicle was located on the west side of the apartment building with the keys on top of the front passenger tire.</p> <p>Based on my investigation, the statements made by Malgorzata, Nikola and Kaja and the totality of circumstance, I developed probable cause to arrest Slawomir Ekert per F.S.S. 784.03(1a1) Simple Battery after he grabbed Malgorzata by the neck and slapped her in the face. Photos of Malgorzata's neck were taken with Officer Papia's MVR which were tagged and submitted into BRPD evidence. Slawomir was transported to BRPD for processing and transported to the Palm Beach County Jail.</p>
