The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/20/20 I made contact with the defendant subsequent to a call for service in reference to a criminal mischief. The defendant was located in the middle of the public roadway of Raintree Blvd near the intersection of Laketree Ln, leaning against the hood of his vehicle. While officers on scene were attempting to investigate the criminal mischief, the defendant repeatedly screamed profanities at the other party who were also on scene. It was clear the defendant was intoxicated as indicated by an extremely strong odor of alcohol coming off his expelled breath and having glassy and bloodshot eyes. He swayed while standing and his behavior was vulgar, abusive and extremely combative. He continued to act erratic and attempted to incite a fight with numerous subjects who were witnesses and parties involved with the criminal mischief. Defendant was asked numerous times to stop his behavior as neighbors were coming outside due to the noise level, and subjects trying to engage the defendant due to his verbal threats towards others. He stated "come on bitch ass nigga I'll beat your ass, and knock your ugly ass sister out too". Defendant intentionally screamed how he would physically assault other parties on scene by saying he would beat their face in. Defendant was identified via FL DL. The defendant was not eligible for APAD due to being extremely uncooperative and did not believe he was creating a disturbance.
