The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 11/02/2019, at approximately 0302 hours, Deputy Shannon conducted a traffic stop at the intersection of Gunn Hw / Jana Dr on a 2005 red Ford Expedition bearing FI tag NAPN30 (VIN:1FMPU155X5LA93169) for driving on the wrong side of the road. Deputy Shannon observed the defendant operating the vehicle and detected signs of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. After a 20 minute observation, the defendant provided a lawful breath sample that resulted in a BAC of .152/.155. The defendant was identified via FL DL.
