On the above listed date and time, detectives were conducting an undercover operation at a hotel within the area of the listed location. A fictitious advertisement was created and posted on a common adult escort website. The defendant made contact with an undercover detective via text who was posing as a prostitute. The defendant negotiated with the undercover detective in order to respond to the hotel which was being utilized during the operation. Upon contact with the defendant he negotiated with the undercover detective and provided her with \$140.00 in US currency to have sexual intercourse and oral sex without a condom for one hour. The defendant immediately became paranoid, took the money from the undercover detective and left the hotel. A traffic stop was conducted on the defendant once he left the hotel and he was arrested. A controlled phone call was placed to phone number 813-303-7134 (number used to text with the undercover detective) and the phone the defendant was in possession of rang with the HCSO covert cellular number displayed on the screen. The Defendant was identified via DAVID.
