On 03/29/2022 at approximately 0200 hours, this Officer was conducting a speed enforcement selective in the area of the 2800-block of PGA Blvd, PBG, FL, when a vehicle was observed traveling east bound, in the outside through lane at an increased rate of speed. Body worn camera and in car video were activated upon traffic stop. This Officer visually esimated at approximately 70 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), front antenna (KC086606) this Officer received a steady tone and reading of 68 MPH, increasing to 69 MPH and remaining at 70 MPH. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer entered the lane behind the vehicle, a white Jeep (PGQ053/FL) and observed the vehicle stop at a red light in the right turn lane at the intersection of Ellison Wilson Rd. When the light changed to green, the vehicle proceeded straight from the dedicated right-hand turn lane, continuing east bound on PGA Blvd. This Officer then observed the vehicle make a right-hand turn onto US Highway 1, where a traffic stop was conducted in the 11400-block of US Highway 1, PBG, FL. This Officer made contact with the driver and sole occupant of the vehicle, identified via Florida Driver License photo, Sophia Sheikh (OF), while she was still in actual physical control of same. Sheikh had glassy watery eyes, flushed face to the extent of sweating, and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. At times, Sheikh also spoke very quickly. Sheikh said she was coming from West Palm Beach and was on her way to a friends house. Sheikh denied consuming alcohol on this night. Based on this Officers observations, Sheikh was asked to participate in Standardized

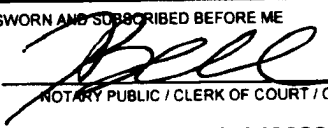
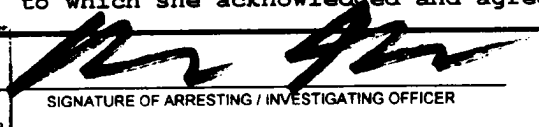

Field Sobriety Exercises, to which she complied. Sheikh said she did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3 with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Sheikh had Vertical Gaze Nystagmus in both eyes as well as lack of convergence in both eyes, twice. The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. Sheikh moved in the starting position and removed her right foot from the line. During the turnaround, Sheikh spun around, rather than taking a series of small steps. During the return set of steps, Sheikh missed heel-to-toe one time. The third exercise conducted, was the One-Leg Stand. During the exercise, Sheikh raised her left foot. Sheikh had to be told to raise her foot higher and look at her raised foot. Sheikh raised her hands more than six inches from her side and swayed. The fourth exercise conducted, was the Finger to Nose. During the exercise the following observations were made: during all six commands, Sheikh touched under the tip of her nose, with the side of her corresponding finger. Sheikh also had to be told to lower her hand after each command. Sheikh had eye lid tremors in both eyes during the exercise. The fifth and final exercise conducted, was the Modified Rhomberg Balance. Sheikh estimated 30 seconds in approximately 22 seconds. Sheikh again had eye lid tremors in both eyes. Based on this Officers observations, Sheikh was placed under arrest at 0223 hours. During a tow inventory of the vehicle, Ofc Lusavich 513 discovered contraband. In the black purse on the front passenger seat, was a clear plastic baggy containing a white powdery substance. This substance later field tested positive as Cocaine. On the front passenger seat, Ofc Lusavich also discovered a single green rectangular tablet stamped "S 90 3", which based on this Officers training and experience was Alprazolam. Under the driver seat, this Officer discovered a white plastic tube labeled as THC. The interior had a small amount of a green leafy substance which had the distinct odor of fresh Cannabis. The tablet and powdery substance were seized as evidence and booked as same, by this Officer. At the PBSO BAT this Officer requested Sheikh to provide a breath sample for the purpose of determining its alcohol content, to which she asked what her options were. This Officer read Florida Implied Consent to Sheikh, to which she acknowledged and agreed to

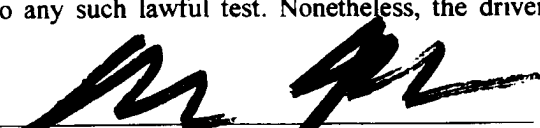

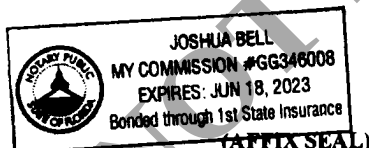

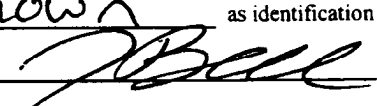
