The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 28 day of MAY, 2020,

at approximately 9:58 AM, at 800 BAYWAY BLVD, in Pinellas County did:

UNLAWFULLY HAVE IN HIS ACTUAL OR CONSTRUCTIVE POSSESSION, A SUBSTANCE DEFINED BY FLORIDA STATE STATUTE CHAPTER 893, TO WIT: XANAX 2MG, WITHOUT HAVING LAWFULLY OBTAINING SAID SUBSTANCE FROM A VALID PRACTITIONER. THE SUBSTANCE WEIGHED 2.3 GRAMS.

THE PILLS WERE IDENTIFIED THROUGH DRUGS.COM

AFFIANT RESPONDED OUT TO THE POOL OF THE ABOVE LOCATION FOR A REPORT OF DRUGS FOUND IN THE AREA. UPON ARRIVAL, AFFIANT LOCATED SEVERAL CRUSHED PILLS OF XANAX 2 MG. WITNESSED ADVISED THAT A MALE FROM UNIT 29 HAD JUMPED OVER THE POOL FENCE AT AROUND 0300 HOURS AND WAS KICKED OUT. WITNESS PROVIDED A DESCRIPTION THAT MATCHED THE SUSPECT. AFFIANT MADE CONTACT WITH SUSPECT AND DURING A CONSENT SEARCH OF HIS WALLET, AFFIANT LOCATED WHITE POWDER RESIDUE IN THE BILL FOLD. DEFENDANT WAS INTERVIEWED AND ADMITTED TO JUMPING OVER THE POOL FENCE AND BEING IN POSSESSION OF THE XANAX. DEFENDANT DID NOT HAVE A VALID PRESCRIPTION AND ADMITTED TO PURCHASING 15 PILLS OF XANAX FROM AN UNKNOWN SUBJECT THE NIGHT BEFORE. DEFENDANT PAID \$7 A PILL. DEFENDANT WAS COOPERATIVE WITH THE INVESTIGATION.

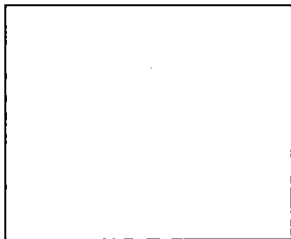
