The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 12/31/20, at approximately 0016 hours, Deputy B. Shannon conducted a traffic stop at the location of 8230 of Dale Mabry Hw N FL 33614 on a 2010 blue Nissan SUV bearing TN-tag V2626A (expired) (VIN:5N1AN0NW3AC523267) after he observed the vehicle being operated with an out of state tag expired tag. Upon contact with the driver, Deputy Shannon observed the defendant operating the vehicle and detected signs of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. The defendant was then transported to CBT and asked to provide two lawful breath samples which the defendant initially refused to provide. Post implied consent the defendant agreed to provide a lawful breath sample. After a proper 20 minute observation the defendant provided two breath samples that resulted in a BAC of .034/.034. The defendant was then asked to provide a lawful urine sample which she refused. Post implied consent the defendant still refused to provide a lawful urine sample. The defendant was identified via FL DL.
