The defendant was driving a white 2017 Ford Fusion (FL TAG #JBCV54) eastbound on 17th Av E. This section of 17th Av E is a 1-way road with westbound traffic only. During the traffic stop for driving the wrong way, the defendant drove up onto a sidewalk and almost struck a parked pick-up truck. He was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, droopy eyelids, blank/dazed stare, sleepy/tired appearance, moved with slow/deliberate movements, had poor balance, admitted to drinking "2 Malibu & Cokes" at the Southern Nights bar in Ybor City, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent and provided 2 valid breath samples, measuring .085/.087 BrAC.
