The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the named Defendant, Stephanie Bedran Gatos, on Sunday, the 25 day of April, 2021, committed the above violation(s), of law.

GIVING FALSE NAME TO LAW ENFORCEMENT

NARRATIVE DESCRIPTION (IF SUPPLEMENTAL)

On Sunday, April 25, 2021, I, Officer E. Cernuto, along with Officers D. Morgan and M. Leon of the Florida Fish and Wildlife Conservation Commission (FWC), was conducting vessel patrol in vicinity of Lake Boca, located in Palm Beach County, Florida.

While underway, I observed the defendant on the rear of a jet-ski, with her Personal Flotation Device (PFD) unsecured. Noting this, we then advised her she would need to secure her PFD. The female appeared to be attempting to take a photograph of herself, disregarding our lawful

We then conducted a vessel stop, in order to address the violation, at which time she was still attempting of still take a photo (or other video, social media post, etc). of herself. Throughout our stop, Ms. Gatos attempted to ask us if she could "just pay us" her ticket, asking if she could just give us money. Upon running the name provided by Ms. Gatos, who advised her identification was out of NY (Sophia B Garcia, 09/05/2000), it came back with No Record Found. Per Ms. Gatos, she was only in town of a few days and was going back to NY tomorrow. When asked her address, Ms. Gatos initially struggled to provide an address, stating she had "just moved".

Upon querying the name out of Florida and New York, the name continued to come back with No Record Found. Upon asking Ms. Gatos to provide her telephone number, she advised a number with a "954" area code. When questioned as to why she had a Broward County area code, she advised that she had "just gotten her phone". Noting that the story provided by Ms. Gatos did not appear to be factual, I then asked her to show me her social media, to verify her name. She then advised she didn't have social media.

I then advised Ms. Gatos that we were going to have her come onboard our vessel until we could identify her, at which time she refused. I then grabbed Ms. Gatos left arm, at which time she, braced, pulled away and tensed. Upon getting Ms. Gatos onboard our vessel, she continued to provide false information and was yet to be identified.

While underway, Ms. Gatos began to dry heave and breathe heavily, as if hyper ventilating. Based on this, we then requested EMS response to Silver Palms, in order to assess Ms. Gatos medical condition. Ms. Gatos was subsequently medically cleared by Palm Beach County Fire Rescue. Following medical clearance, Ms. Gatos was identified via Rapid Identification.

Ms. Gatos was charged with Providing False Name to Law Enforcement pursuant to Florida State Statute 901.36(1) and Resist Arest Without Violence pursuant to Florida State Statute 843.02. Ms. Gatos was transferred over to Boca Raton Police Department for transport to the Palm Beach County Jail.
