

On the 4 day of June, 2020 at 03:09 (Specifically include facts constituting cause for arrest.)

On Thursday, June 4, 2020, at approximately 11:57 p.m., I Officer Romero, was conducting patrol in the vicinity of Northlake Blvd and Hiatt Dr. in Palm Beach Gardens, Palm Beach County, Florida. Due to recent events in the country, the city of Palm Beach Gardens declared a State of Local Emergency for the city. During the State of Local Emergency, there is a curfew in effect between the time of 10:00 p.m. and 6:00 a.m. for the entire city. At the about mentioned time, I observed a black SUV bearing Florida tag: JNEZ17, driving westbound on Northlake Blvd. A DHSMV records check on the vehicle revealed the vehicle was the subject of Florida Issued Seize Tag order. The records check also revealed that the registered owner of the vehicle had a suspended driver's license. I drove my patrol car along the driver's side of the vehicle and positively identified the registered owner as the motor vehicle operator. I activated my emergency overhead lights and conducted a traffic stop.

Upon approach to the vehicle, I observed a black male seated in the driver's seat. The male was identified as Elinor Innocent (DOB: 05/05/70). Elinor is a Taxi driver. While explaining to Innocent the reason for the stop, the passenger seated behind the driver's seat, opened the window, and spontaneously offered to identify herself. The female was holding a multicolored wallet on her hands. As she was trying to retrieve her identification card, the interior of the wallet was exposed, and I was able to observe a plastic bag containing what appeared to be a white powdery substance in it. I asked all occupants out of the vehicle to investigate further.

Outside of the vehicle, I asked for the male's identification, which the female stated is in his wallet. As I was walking to get the male's ID, I asked him if it was okay to get his ID from his wallet, and he answered yes. The female was identified as Stephanie Marie Hinkle (DOB: 09/02/1984), and the male was identified as Richard Catanzaro (DOB: 08/07/1958). While looking for the male wallet, I located the same multicolored wallet that the female was holding in her hands while I was standing next to the window. Inside

<p>the female's wallet, I found a plastic bag containing a white powdery substance and a lipstick containing a plastic bag inside with a white powdery substance. The white powdery substance, based on my training and experience, appeared to be suspected cocaine. Each white powdery substance was field-tested by officer Johnston using a NARK II field test kit and yielded a presumptive positive for cocaine. The total weight of the suspected cocaine found on Hinkle's wallet was 2 grams. Post Miranda, Hinkle admitted ownership of all items, stating that it was for personal use.</p> <p>On Catanzaro's left side pocket, I located a small plastic bag containing a white powdery substance. The bags containing the white powdery substance based on my training and experience appeared to be suspected cocaine. The white powdery substance was field-tested using a NARK II field test kit and yielded a presumptive positive for cocaine. The total weight of the suspected cocaine was 1.6 grams. Post Miranda, Catanzaro admitted ownership of the bag, stating that it was for personal use.</p> <p>All contraband was packaged appropriately and submitted into the Palm Beach Gardens evidence department as evidence.</p> <p>The driver, Innocent, provided a sworn statement. Innocent stated that while I was approaching the vehicle, the female (Hinkle) told the male (Catanzaro), "you need to get it" and was trying to pass something to Catanzaro, which Catanzaro refused to take. Innocent was unsure as to what Hinkle was trying to hide. I issued Innocent a warning for the suspended license, and he was released from the scene. The tag of the vehicle was seized, and the vehicle was removed from the scene by Kauff's Towing.</p> <p>Based on the above facts, probable cause exists to arrest Richard Catanzaro with (1) count for possession of cocaine pursuant to F.S.S.893.13(6)(A).</p> <p>Based on the above facts, probable cause exists to arrest Stephanie Marie Hinkle (with (1) count for possession of cocaine pursuant to F.S.S.893.13(6)(A).</p> <p>Catanzaro and Hinkle were transported to the Palm Beach County Jail without incident.</p>
