The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a black 2020 Toyota C-HR, 4 door, Florida tag CULV26. The defendant approached traffic stopped for a steady red traffic light and she failed to stop in time, striking the rear end of a black 2013 Dodge, 4 door, Florida tag LEHK94 (registered to the victim), causing an estimated \$4,000.00 in damages. The driver of the Dodge identified the defendant as the driver of the vehicle at the time of the crash, and TPD MPO Furby (49946) arrived on scene to find the defendant in the driver seat of her vehicle, engine running, and she was the sole occupant. During the crash investigation MPO Furby made observations of impairment such as the odor of an alcoholic beverage coming from the defendant's breath, bloodshot and watery eyes, blank stare and confusion, slurred speech, and an inability to focus and multi-task. I responded to the scene in the capacity of a DUI Investigator. Upon making contact with the defendant I could smell the distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and her speech was slurred. The defendant had a blank stare about her, and seemed disoriented. The defendant visibly swayed even while sitting in the vehicle. The defendant was unsteady exiting the vehicle, her gait was unbalanced, and she swayed noticeably while standing. The defendant was advised that the civil crash investigation was complete and a criminal DUI investigation was now being conducted. She was also advised of her Miranda Rights, in which she did decline to answer questions without an attorney. The defendant did agree to submit to Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and she had difficulty following simple instructions. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant provided breath samples of .289% BrAC and .277% BrAC. The defendant was positively identified by her Florida DL.
