 On the above listed time and date, at the above listed location, the defendant was standing in the kitchen when her biological mother/victim, Ollie Williams, asked her about her drug use. The defendant became enraged and grabbed Ollie Williams around her neck with both hands while pushing her against a stove and eventually forcing her to the ground. Ollie Williams' fiancé, Ronald Drake, witnessed the defendant over Ollie Williams and pulled her off. The defendant proceeded to punch Ronald Drake three times in the right side of his face with closed fists and grabbed him around his neck. While the defendant had her hands around Ronald Drake's neck, he stated he could not breathe. The defendant's actions were against the will of both victims. The defendant and both victims have been residing as a family at the above listed location for over two years. The incident was witnessed by the defendant's fourteen-year-old son. Both victims positively identified the defendant as the person who committed the offense. The defendant's identity was confirmed via her DHSMV Photograph.
