The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a dark green 2015 Ford Fusion, 4 door, Florida tag MTLHEDD. The defendant drove in a manner in which the vehicle drifted far left and far right in the travel lane several times, was weaving in the travel lane, crossed onto painted lane markers several times, drove the right side tires completely off the roadway once and touched the edge of the roadway twice, and she had difficulty maintaining a consistent speed as the vehicle speeds increased and decreased sporadically. The defendant drove at speed visually estimated and TPD unit 5055 paced at 51 MPH in a properly posted 40 MPH speed limit. A traffic stop was initiated to check on the condition of the driver to determine if she were sick, tired, distracted, or impaired. The defendant stopped at a red light during the traffic stop, at which time she was advised several times by patrol car PA system to turn into a closed business parking lot. The defendant failed to understand or follow this command. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and her speech was slurred. The defendant had difficulty multi-tasking and was easily distracted, she fumbled with documents displaying poor dexterity, and she was forgetful as related to requested documents. The defendant stated she drank "four or five" alcoholic beverages tonight. The defendant was unsteady exiting the vehicle, and she swayed noticeably while standing. The defendant's upper body was wobbly as she stood. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances was arrested for DUI. The defendant provided breath samples of .202% BrAC and .210% BrAC. The defendant was positively identified by her Florida DL.
