The defendant was observed to be driving a black 2018 Jeep Cherokee SUV (NY TAG #HMU5030) westbound on Platt St W at Newport Av S. This section of Platt St W is a 1-way road with eastbound traffic only, and the defendant was driving head-on towards eastbound traffic. During the traffic stop for the wrong-way infraction, she was identified via a NY DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, slurred speech, poor balance, admitted to drinking a "Tito's vodka mixed drink" while at The Patio Bar (her place of employment), and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she provided 2 valid breath samples, measuring .153/.157 BrAC.
