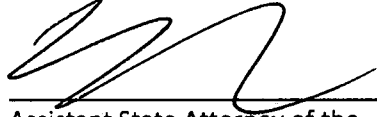

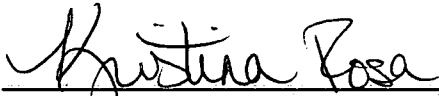

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/07/21 at approx. 1920 hrs, subject Stephanie R. Evans, was going through lane 3B of the Transportation Security Screening in Airside E, Tampa International Airport. Upon x-ray inspection of her bag, a brown Louis Vitton bag, TSA did observe what appeared to be a loaded firearm concealed within the bag. Upon search of the bag, a fully loaded Ruger LCP .380 caliber firearm was discovered. The firearm had one round chambered and five in the magazine. The firearm was in a black holster. Upon securing the firearm, Evans was asked if she had a concealed carry permit in Florida. Evans stated no and records check revealed negative results. Evans subsequently did carry a concealed firearm on or about her person and is not licensed.
