NARRATIVE:

On Sunday July 11, 2021 at approximately 0600 hours, I responded to 2838 Nokomis Avenue, Unincorporated West Palm Beach, Florida, within Palm Beach County, reference to a domestic dispute. The caller stated her mother Stephanie Vivar DOB: 4-23-1977 had left with her fathers car and was out of control. Let it be noted, it was later to be determined that Stephanie drives this vehicle on a normal basis.

Upon arrival at approximately 0610 hours, myself and D/S C. Butterworth, #16040, made contact with Carlos Vivar and the couples 16 year old daughter. Carlos stated his wife Stephanie Vivar was home and became angry at him and started tearing up the residence throwing glass and pots around the residence. Stephanie had left prior to our arrival in a green Toyota Tundra pickup truck FL. TAG LBIW47. While standing outside the residence with D/S C. Butterworth, Carlos Vivar, and the couples 16 year old daughter discussing what had transpired, Stephanie was scene driving the green Toyota Toyota Tundra in the 2800 block of Nokomis Avenue westbound past the residence traveling at approximately 55 MPH in a 25 MPH, screeching her tires, in the wrong lane of oncoming eastbound traffic. She then failed to yield to the posted stop sign at Nokomis and Wabasso Drive. I immediately entered my vehicle, turning my lights and sirens on effecting a traffic stop. The vehicle came to a stop in the 3800 block of Nokomis Avenue, just west of Wabasso Drive.

I approched the drivers side door where I asked Stephanie to exit the vehicle. She refused to exit. I asked her again where she refused. I then grabbed her left arm and escorted her out of the vehicle where she was placed in handcuffs which were double




locked, checked for tightness, and proper fit. She did not complain of injury nor was any force used. Let it be noted, Stephanie was very upset during the arrest cursing and yelling the entire time.

While D/S Piantoni, ID 33106 was bringing her from D/S Butterworths car to his, Stephanie was told approximately 5 times to get into the vehicle which she refused. We then had to place her in the vehicle by grabbing her arms.

Based on the above circumstances, I find probable cause to charge Stephanie Vivar with Reckless Driving pursuant to F.S.S. 316.192 (1a) and two counts of Resisting Arrest without Violence pursuant to F.S.S. 843.02 as she refused to exit the vehicle and refused to enter the patrol vehicle after several commands given during an investigation. Stephanie was transported to the Palm Beach County Jail.
