



On 9/26/2020 at approximately 1848hrs I responded to 126 Day Lilly Drive, Jupiter, Palm Beach County, Florida in reference to a violation of injunction call.

Upon arrival I was in full Jupiter Police Department Uniform with my Department issued Axon Body Worn Camera activated. I made contact with the caller who was positively identified as WF Lauren E. King 3/17/85. King stated in a sworn verbal statement that she noticed on Instagram today that her ex (WM Stephen E. Walker 8/21/77) had violated her Injunction on Stalking Violence by coming within 500 feet of her place of employment. King explained that when she saw a post on Instagram she contacted her boss, WM Jeremy R. Howard 4/26/83, to see if Walker was in fact there. Howard texted her explaining that he had been there briefly today. King was upset about this as Walker came near her a few days ago on the beach. King requested police action as she feel that Walker violated the injunction twice by going to her place of employment twice in a short time period.

I then made contact with Howard on Clemons Drive in Jupiter Florida at the business main office. Howard provided a sworn verbal statement. Howard explained that Walker showed up with a group of friends to record live music at the business location as many people record live music for advertisements. Howard stated that he let King know that Walker had shown up with a group of friends. Howard explained that he saw Walker for a brief time before he believed he left. At this point Howard made contact with other parties and asked if Walker had left and he was told he went to go get food. Howard informed the other parties that Walker was not supposed to be there due to ongoing court stuff. After a short time Walker returned with food before ultimately leaving with his group of friends. Howard explained that the business location is a spot that King may or may not

<p>be at during any given time period. Sometimes she is there every day of the week and other times she will not be inside the office for weeks at a time as she is a realtor. Howard had no further information of value.</p> <p>I then attempted to make contact with Walker at his residence. Walker invited officers into his residence and appeared to be confused about why we were there. I asked Walker if he had gone to the brokers office off of Clemons Drive to which he initially denied. He explained he was near the office and eventually admitted to dropping off friends there and explained he went to Square Grouper. Walker was asked why the police were there and I informed him that I was investigating a potential violation of an injunction. Walker immediately explained that he had transcripts from his hearing when issued the injunction that contradicted the place of employment portion of the injunction. Walker showed me on a copy of the transcripts from the hearing. In the hearing Walker rises the issue of King not having a true place of employment as she is a realtor. The court raises the question to King if she has a place of employment and she explains it is technically her office but states she is never there so it is not a big concern of hers. The court then replies that it is not an issue then. Therefore Walker believed that he was allowed to be within 500 feet of the place of employment and was able to go around there as long as he was not attempting to intimidate King. Walker was advised he should return to court to have this issue of the place of employment clarified by the judge.</p> <p>Based upon the entire investigation and statements made by all parties involved, this case is being forwarded to the Palm Beach County State Attorney's Office for review.
