On 12/17/2019, at approximately 2306 hours, Deputy M. Taber ABN 256562 arrived at 8405 Stillbrook Av in Tampa, FL in reference to a person down call for service. The comments of the call stated "Subject passed out in Toyota Camry in front of this location unknown if breathing." Deputy Taber observed a silver Toyota FL tag LXVK55 (VIN:2T1BR38E04C210724) in front of the above listed address. Deputy Taber observed the defendant slumped over in the driver seat and the sole occupant of the vehicle. Deputy Taber noted that the vehicle was on and the keys were in the ignition. Deputy Taber announced "Sheriff's Office" multiple times and was able to wake the defendant. When the defendant regained consciousness, he had the distinct odor of an alcoholic beverage emanating from his person, he was lethargic, and disoriented. Affiant responded to the scene, detected signs of impairment, and followed Hillsborough County Fire Rescue (HCFR) to Tampa Community Hospital (TCH) due to the defendant's sugar levels being abnormally high. The defendant received medical attention at the Emergency Room of TCH, and was medically discharged approximately one hour after arriving. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to perform. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a lawful sample of his breath to determine his breath alcohol content (BrAC). Breath Technician Dail ABN 254236 provided me with the BrAC results and they are as follows: First BrAC sample (.224) ; Second BrAC sample (.214). The defendant was identified via NY ID card. The defendant received DUI Citation AD0BQEE which reflects the DUI citation.
