DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Ofc Ray 415, observed the vehicle, a Toyota pick-up (IASC85/FL) traveling at 63 MPH in a posted 45 MPH zone. Ofc Ray further advised, the vehicle was changing lanes repeatedly for no apparent reason and had rapid variations in speed. Upon Ofc Ray's contact, the driver handed him his driver license and a check, rather than his registration. I made contact with the driver, identified via Florida Driver License, Stephen Dugas, while he was still in the driver seat of the vehicle while it was still on and running.

OBSERVATION OF DRIVER:

Dugas had a bloodshot watery eyes, flushed red face, slurred speech and the odor of an unknown alcoholic beverage emanating from his breath at conversational distance.

DRIVER'S STATEMENTS:

Dugas said he was coming from up the road and did not consume any alcoholic beverages.

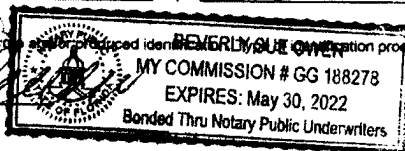

WALK & TURN:

During the instructions, Dugas stepped off the line, raised his arms and was unable to maintain the starting position multiple times. Dugas also started the exercise early three times. During the first set of steps, Dugas missed heel-to-toe on seven steps. Dugas also had his arms raised more than six inches from his sides. After the ninth step, Dugas stopped and awaited further instructions. After the turnaround, Dugas then stepped off the line. On the fourth step, he missed the line and had to stop to regain his balance. Also on the sixth step, he stepped off the line again. Dugas took eight steps rather than nine as instructed. During the return set, Dugas also had his arms raised more than six inches from his sides.

ONE LEG STAND:

Dugas started the exercise early. Dugas had his raised leg bent at the knee for the duration of the exercise. Dugas had his arms raised well over six inches from his sides during the exercise. Dugas put his foot down three times prior to being told to do so. Also during the exercise, Dugas hopped several times.

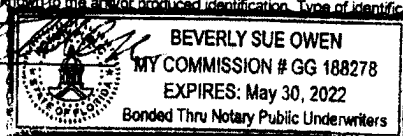

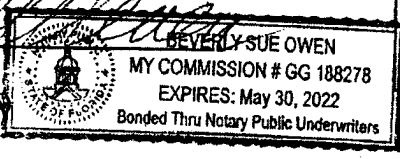
