The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/11/2020, at approximately 0003 hours, at Natures Way Bl / Eastridge Dr, Valrico, FL 33594, Deputy Price #252762 conducted a traffic stop on a 2016 white Ford Mustang (TX tag: GSV3386 / VIN: 1FA6P8AM8G5256511) for speeding, having an expired tag (UTC #0344WKJ) and running a stop sign (0410WKK). I assisted Deputy Price as a backup unit and as I made contact with the driver, I observed him to have a severe odor of an alcoholic beverage on his breath, slurred speech, and slightly red / glossy eyes. Based on the indicators of impairment, field sobriety exercises were conducted, further impairment was observed and the driver was subsequently arrested for DUI. While at CBT, the defendant provided two breath samples, yielding results of .329 / .326 BAC (after a twenty-minute observation period). The defendant was positively identified via his Florida driver's license. Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge.
