On 04/22/2022 at approximately 0231 hours this Officer responded to the parking lot of Swampgrass Willies 9910 Alt A1A, PBG, FL to assist Ofc Hennessy 409 with an investigation. Body worn camera and in car video were used. This Officer arrived and observed Ofc Hennessy standing next to a BMW utility vehicle (GHVK04/FL) with an individual unconscious behind the wheel, while the vehicle was on and running with the gear shifter in park. Officers conducted a welfare check on the driver to determine if he was sick, injured or impaired. It took several attempts, however, Officers were able to awaken the driver, who was identified via Ohio Driver License photo, Steven Hutson (OF), who was in actual physical control of the vehicle. Hutson appeared highly intoxicated, by having bloodshot watery eyes, flushed red face, slow lethargic movements, being completely disoriented and not knowing where he was located. This Officer was also able to detect the very strong obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Hutson was intoxicated to the point of not being able to answer simple questions. His speech was low, slurred and gurgled. Based on this Officers observations, Hutson was removed from the vehicle by Officers, since he was seemingly unable to exit the vehicle on his own, to participate in Standardized Field Sobriety Exercises. As soon as Officers let go of Hutson, he lost his balance and fell against the driver side of his vehicle. Hutson said he did not have any medical conditions which would affect the exercises performed. The first exercise to be performed was the Horizontal Gaze Nystagmus. Hutson was unable to stand upright. Hutson swayed orbitally, stumbled backward and was caught by Ofc Hennessy. Hutson then fell forward toward this Officer. At this time, this Officer made the determination Hutson could not safely participate in exercises due to his level of impairment. Hutson was immediately placed under arrest at 0237 hours. When

	Officers retrieved Hutsons phone to place with his property, Apple Maps navigation was active showing navigation directions from the current location to an unknown destination over 14 hours and 1,000 miles away. Once this Officer arrived at the PBSO BAT, this Officer noticed Hutson had regurgitated in the back seat of the unit. This Officer had to assist Hutson from the vehicle to the PBSO BAT. Hutson lost his balance several times, however, this Officer prevented him from injuring himself on the floor. This Officer requested Hutson to provide a breath sample for the purpose of determining its alcohol content to which he refused. This Officer read Florida Implied Consent to Hutson, to which he acknowledged and again refused at 0340 hours. Due to Hutsons level of impairment, he was medically cleared for incarceration at JFK Midtown. Based on the results of the investigation, this Officer has probable cause to prove Steven Hutson was in actual physical control of a motor vehicle, in the state of Florida, while under the influence to the extent his normal faculties were impaired, in violation of FSS 316.193(1) (A).

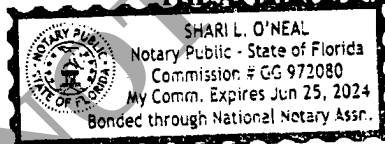

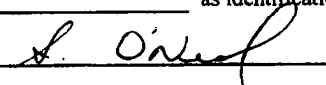
