On 04/16/2022 at approximately 0053 hours, this Officer arrived in the area of Northlake Blvd and Green Meadows Way, PBG, FL, to assist Ofc Sheobo 524 on a traffic stop. Body worn camera and in car video were used.									
Ofc Sheobo said he observed the vehicle, a Chevrolet pick-up truck (KP2P92/FL) disobey a steady red light at the intersection of Northlake Blvd and Keating Dr, PBG, FL. Ofc Sheobo further stated the same vehicle then almost rear-ended a motorcycle at the intersection of Northlake Blvd and N Military Trl, PBG, FL. Once Ofc Sheobo activated his overhead red and blue lights, Ofc Sheobo said the vehicle was slow to stop, eventually stopping at the location. This Officer made contact with the driver, identified via Florida Driver License photo Steven Dunn (OF), while he was still in actual physical control of the vehicle. This Officer observed Dunn to have red watery eyes, slurred speech, flushed red face, and the strong obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Dunn said he was coming from "The Woods" restaurant and was on his way home. When asked how much he had to drink tonight, he replied "not a lot".									
Based on this Officers observations, Dunn was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. Dunn said he did not have any medical conditions which would affect the exercises and mentioned wearing contact lenses.									
The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3 with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Dunn also had the onset of Nystagmus prior to 45 degrees in both eyes.									
The second exercise conducted, was the Walk and Turn. The line used was a strip of

yellow tape placed upon the pavement by this Officer. During the instructions, Dunn lost his balance and stepped out of the starting position. Dunn also started the exercise prior to being told to do so. During the first set of steps, Dunn raised his arms more than six inches from his sides and missed heel-to-toe twice. During the turnaround, Dunn turned in the opposite direction and moved his planted foot. During the return set of steps, Dunn again raised his arms more than six inches from his sides and missed heel-to-toe three times. The final exercise conducted, was the One-Leg Stand. During the exercise, Dunn raised his right foot. Dunn swayed throughout the exercise and raised his arms more than six inches from his sides. Dunn also placed his foot down twice prior to being told to do so. Based on this Officers observations, Dunn was placed under arrest at 0104 hours. At PBSO BAT, this Officer requested Dunn to provide a breath sample to determine its alcohol content, to which he agreed to do so. At 0152 hours he blew .145 and at 0155 hours he blew .141. Based on the results of the investigation, this Officer has probable cause to prove Steven Dunn operated a motor vehicle, in the state of Florida, while under the influence to the extent his normal faculties were impaired with an unlawful breath alcohol content, in violation of FSS 316.193(1) (C).
