On the <u>7</u> day of <u>May</u> , <u>2020</u> at <u>20:00</u> (Specifically include facts constituting cause for arrest.)							
On Thursday, May 7, 2020, at approximately 6:30 p.m., North Palm Beach NET Detective Ciezak and I were conducting surveillance at 725 Hummingbird Rd North palm Beach FL, 33408, a known drug house. I observed grey in color older model Nissan Maxima bearing FL tag (AQCY66) enter the parking lot and park in the space #204. The driver, who was later identified by his FLDL Steven M. Rodgers (w/m 8/12/1987), exited the vehicle then proceeded to apt 204. After a brief stay at the residence Rodgers exited the apartment and appeared to check his left front pocket. He then returned back to his vehicle and promptly began to leave. The vehicle exited the parking area and headed south on Northlake Dr. At that time I contacted North Palm Beach Police Officer (P.O.) Mize and advised him of my findings. P.O. Mize was on patrol in the area and was able to conduct a traffic stop in his marked and equipped North Palm Beach police vehicle.							
P.O. Mize made contact with Rodgers. P.O. Mize identified himself as a North Palm Beach Police Officer, explained the reason for the stop, and asked him for his driver's license, the vehicle registration, and proof of insurance. P.O. Mize advised Rodgers that he was aware of the series of events that had just occurred at 725 Hummingbird Rd. apt 204. P.O. Mize reported that at this time Rodgers spontaneously uttered " I bought coke". Rodgers then proceeded to reached into the rear passenger seat where there was a baby seat and removed four small clear plastic baggies containing a white powdery substance that Rodgers stated it was cocaine. Rodgers was removed from the vehicle and placed under arrest. Rodgers was cuffed behind his back and the cuffs were double locked and checked for proper fit. He was properly and thoroughly searched before being placed into the back P.O. Mize vehicle. Rodgers was wearing a black in colored shirt with black pants and black sneakers.							
At this time Detective Ciezak and I identified ourselves. We explained to Rodgers that we are with the North Palm Beach Police Department. Rodgers appeared to be very nervous, his eyes appeared to be bloodshot and he started to sweat. Post Miranda, Rodgers



provided us with a verbal account of the events that occurred. He stated that after he finished work, he contacted Ward and asked if he could swing by. Rodgers stated that he responded to Ward's house parked in his assigned parking spot and then headed into the apartment #204. He stated that Ward retrieved an AX body spray can and removed a large amount of small baggies containing cocaine. Rodgers advised that he provided Ward with \$150.00 and Ward gave him 4 small clear plastic bags of coke. Rodgers said that he left immediately after purchase.

Based on the above events and investigation, probable cause does exist to charge Rodgers with (1) count of possession of cocaine contrary to F.S.S. 893.13 (1).
