The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 23 day of APRIL, 2020,

at approximately 8:44 PM, at 30 TURNER ST # 303, in Pinellas County did:

DID THEN AND THERE INTENTIONALLY AND UNLAWFULLY THREATEN TO DO VIOLENCE TO SIERRA HOLMES WHILE HAVING THE APPARENT ABILITY TO CARRY OUT SAID THREAT AND DID CREATE A WELL FOUNDED FEAR IN SIERRA HOLMES THAT SUCH VIOLENCE WAS IMMINENT AND IN THE COMMISSION OF SAID ASSAULT DID USE A DEADLY WEAPON, TO-WIT: THE DEF HELD A LOADED BLACK HANGUN TO THE VICTIM'S FOREHEAD AND THEN TO HER TEMPLE AT THE TIME OF THE ASSAULT NOT HAVING THE INTENT TO KILL SIERRA HOLMES.

ON THE ABOVE DATE, TIME AND LOCATION DURING A DOMESTIC DISPUTE ABOUT THE DEF BEING JEALOUS, THE DEF HELD A BLACK HANDGUN TO THE VICTIM'S FOREHEAD AND THEN TO HER TEMPLE AND STATED "YOU'RE NOT GOING TO LIVE." THE VICTIM STATED THAT SHE WAS IN FEAR FOR HER LIFE AND BELIEVED THAT HE WAS GOING TO PULL THE TRIGGER.

IT SHOULD BE NOTED THAT A HANDGUN WAS LOCATED IN A BLUE CASE ON THE BEDROOM FLOOR NEAR THE BED WITH A ROUND IN THE STOVE PIPE POSITION, THE MAGAZINE WAS ON THE BEDROOM FLOOR SAME SIDE OF THE BED WITH A LOADED MAGAZINE. (WINDOW SIDE/SOUTH SIDE OF BEDROOM)

THE VICTIM AND THE DEF HAVE BEEN LIVING TOGETHER IN A ROMANTIC DATING RELATIONSHIP FOR 6 MONTHS.

POST MIRANDA THE DEF ADMITTED TO POINTING THE GUN AT HER BECAUSE SHE WOULD NOT SHUT UP.

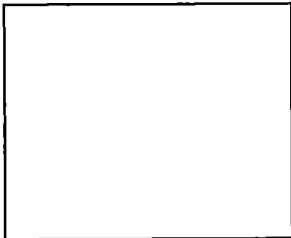
