




(Specifically include facts constituting cause for arrest.)</p> <p>On the above date and time, I was dispatched to the intersection of Lake Ave and South Ocean Blvd which is located in the City of Lake Worth Beach, Palm Beach County, FL in reference to a road rage in which a vehicle struck another vehicle.</p> <p>Upon arrival, I observed a black Mercedes CLA 250 bearing FL Tag "KDAL70", facing southbound on S. Ocean Blvd in the #2 lane just south of Lake Ave, pushed against a red Ford Explorer bearing FL Tag "Y37GTQ" which was pushed up on the sidewalk on the west side of the road. It appeared as if the black Mercedes struck the red Explorer.</p> <p>I then met with the victim, Rafael Mercado, who stated he was driving the red Ford Explorer and was stopped at a red light on Lake Ave and S Ocean Blvd facing eastbound. Rafael observed numerous pedestrians on the sidewalk and was yielding to them so they could cross the sidewalk. Once the light turned green, Rafael waited for the pedestrians to cross but they never did, he stated a black Mercedes which was directly behind him began to honked his horn as soon as the light turned green. Rafael advised the Mercedes then became impatient and swerved around him at a high rated speed. Rafael then began to make the right turn at which time the Mercedes sped up and made an illegal turn and struck his vehicle. Rafael stated he did nothing wrong to provoke the Mercedes to strike him.</p> <p>I then made contact with the second victim and front passenger of the red Ford Explorer, Christine Mercado. Christine stated they were waiting at the traffic light for pedestrians to cross the street at which point the Mercedes which was behind them became upset and honked the horn. The Mercedes then swerved around them real fast and made a right onto S. Ocean Blvd and swerved straight into them, striking their vehicle.</p> <p>I spoke to an independent witness, Elizabeth Treadway, who stated she was the vehicle behind the Mercedes at the intersection facing eastbound on Lake Ave. She stated the Mercedes was stopped directly behind the red Ford Explorer who was first in line. The Mercedes then honked its horn and went around the Explorer who was beginning to make a right turn. The Mercedes then made a hard right turn and struck the Explorer. Elizabeth stated the driver of the Mercedes, later identified as Steven Chesley (defendant) exited his vehicle and began yelling at the occupants of the Ford Explorer.</p>

<p>During my investigation, I was able to review video surveillance footage of the intersection. The surveillance footage shows a red Ford Explorer making a right turn on South Ocean Blvd to go south bound form Lake ave in the inside lane. It then shows a black Mercedes traveling at a high rated speed turn right from the center lane and strike the Ford Explorer. The video shows the wheels of the Mercedes where locked at a 90 degree turn to the right as if aiming to strike the Ford Explorer. The Mercedes then collides with the Ford Explorer, pushing it of the roadway and on to the sidewalk.</p> <p>I then spoke to the defendant and driver, Steven Chesley, and informed him I was initiating a criminal Aggravated Battery investigation and read him his Miranda Rights, using my PBSO issued preprinted Miranda Card. Post Miranda Interview, the defendant stated he was the drier of the black Mercedes. He staeted he was stopped behind the red Ford Explorer at the light facing eastbound. He stated the light turned green and he gave the Explorer about 7 seconds to move forward. He then honked his horn and went on the center lane to go around the Explorer. He stated as he made the right turn onto South Ocean Blvd he could see the Explorer making the turn as well out of the peripherals of his eyes. He then stepped on the gas pedal to accelerate. He then said he lost control as he accelerated and struck the Explorer.</p> <p>Based on the video surveillance footage and positions of the vehicles, the defendant, although making an illegal turn, had ample room to enter his lane of travel without causing a collision. Based on the video and the speed and wheel placement at the time of the turn, it is my belief that defendant purposely and intentionally placed his vehicle in the path of travel of the Ford Explorer.</p> <p>Based on the facts and statements provided to me at the time, I find the defendant violated FSS 316.085(2)- illegal lane change, FSS 784.045-1A2 - Agg Battery- by purposely and willfully using his vehicle as a weapon to strike the victim, FSS 806.13-1B2- by causing damage to the victim's vehicle.</p> <p>I transported the defendant to JFK Medical Center for Medical Clearance and then PBC Main Jail without further incident.</p>
